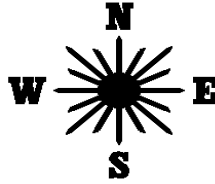

RE: SUNSET STRIP WASTE DEPOT

Council acknowledges with thanks your correspondence dated 24th June 2014 with regard to the formation of a partnership agreement with the Central Darling Shire Council to manage waste at Sunset Strip.

Council has contacted all relevant statutory authorities, and has gained the requisite approval to continue with waste disposal on Lot 4878 DP767618.

A meeting of Central Darling Shire Council senior management staff has perused your suggested partnership agreement, and offers the following notifications for comment.

1. (8) Sunset Strip Progress Association Inc. will undertake maintenance on a fortnightly basis, or as requested, to ensure materials are stored appropriately in the disposal pits
2. (11) Sunset Strip Progress Association Inc. does hold Public liability insurance to the value of \$20 million, of which a copy of the Certificate of Currency will be provided to Council annually
3. (12) Sunset Strip Progress Association Inc. undertaking the work will be covered by volunteers Insurance, of which a copy of the Certificate of Currency will be provided to Council annually.
4. (14) Sunset Strip Progress Association Inc. would undertake the erection of fencing to stop windblown paper providing Central Darling Shire Council transfers the grant funds provided by Crown Lands.

For legal reasons, Council would not be able to re-assign grant monies devolved to it rather Sunset Strip Progress Association Inc. could be the contractor's effecting the work (erection of fencing) under the jurisdiction of Central Darling Shire Council Director of Shire Services, Reece Wilson.

Council must remain responsible for the final acquittal and reporting of grant monies for reasons of accountability.

Other matters not the subject of your correspondence but requiring consideration/response are:

1. Sunset Strip Progress Association Inc. provide Central Darling Shire Council with a volumetric survey prior to the commencement of the agreement and at intervals not exceeding 6 Months thereafter.

To ascertain volumes/tonnages dumped to ensure disposal quantities remain within parameters set by EPA for exempt landfills.

2. Sunset Strip Progress Association Inc. to provide waste receptacles (eg. wheelie bins) at their own full cost should it be intended to provide residents with bins. This includes any bins which may currently be the property of Central Darling Shire.
3. This partnership agreement is subject to a review by both parties nominally at no longer than 5 years. This may be lessened at any time at the specific request of either party due to changed circumstances, operational difficulties, or legislative changes.

Council looks forward to a mutually beneficial partnership, once all matters have been discussed and resolved to mutual satisfaction.
