**Access roads to Menindee & Copi Hollow Caravan Parks  
and Sunset Strip**

It has been brought to our attention by the Office of State Water that they have received complaints regarding the condition of the access road into Copi Hollow Caravan Park. They have advised that in the past they have maintained the access but will not be in a position to continue that maintenance into the future.

Investigation in this office has raised several issues regarding that park, along with access to the Menindee Caravan Park and the recreational area of Sunset Strip from the Menindee – Broken Hill Road.

Records held in this office indicate that none of these accesses have been formally identified or dedicated as public road.

As you are aware the Legal Roads Network project has as part of its charter the identification and dedication of a public access system across the Western Division. We would see the subject access as falling into that category.

However that formal identification and dedication as public road would vest the lands in the local roads authority, that being Central Darling Shire. Along with that would come the responsibility of care, control and management of these roads.

This Department would like to hear what Council's position is regarding the proposal before any action is initiated. Would Council be prepared to assume management of these public accesses ?

It would be appreciated if Council could give this request some priority to enable us to move forward with a strategy to resolve this issue.

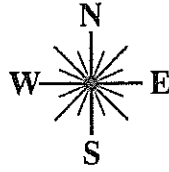

**Re: Roads to Menindee & Copi Hollow Caravan Parks and Sunset Strip**

Thank you for your letters of 3 March and 4 May 2012 regarding the above roads.

As yet, Council has not formed a position on whether it believes it should assume the responsibility for the care, control and management of the access roads to Menindee & Copi Hollow Caravan Parks and Sunset Strip.

Despite the unresolved nature of the responsibility for the Copi Hollow road, Council has recently undertaken some minor maintenance work on that road in response to a request from a road user.

In the meantime, we will commence our investigations into the status of those roads from Council's perspective and contact you when we have a clearer position. Given that Council's next meeting is on 29 June, we will attempt to have a report presented to Council on this matter, for decision if necessary.

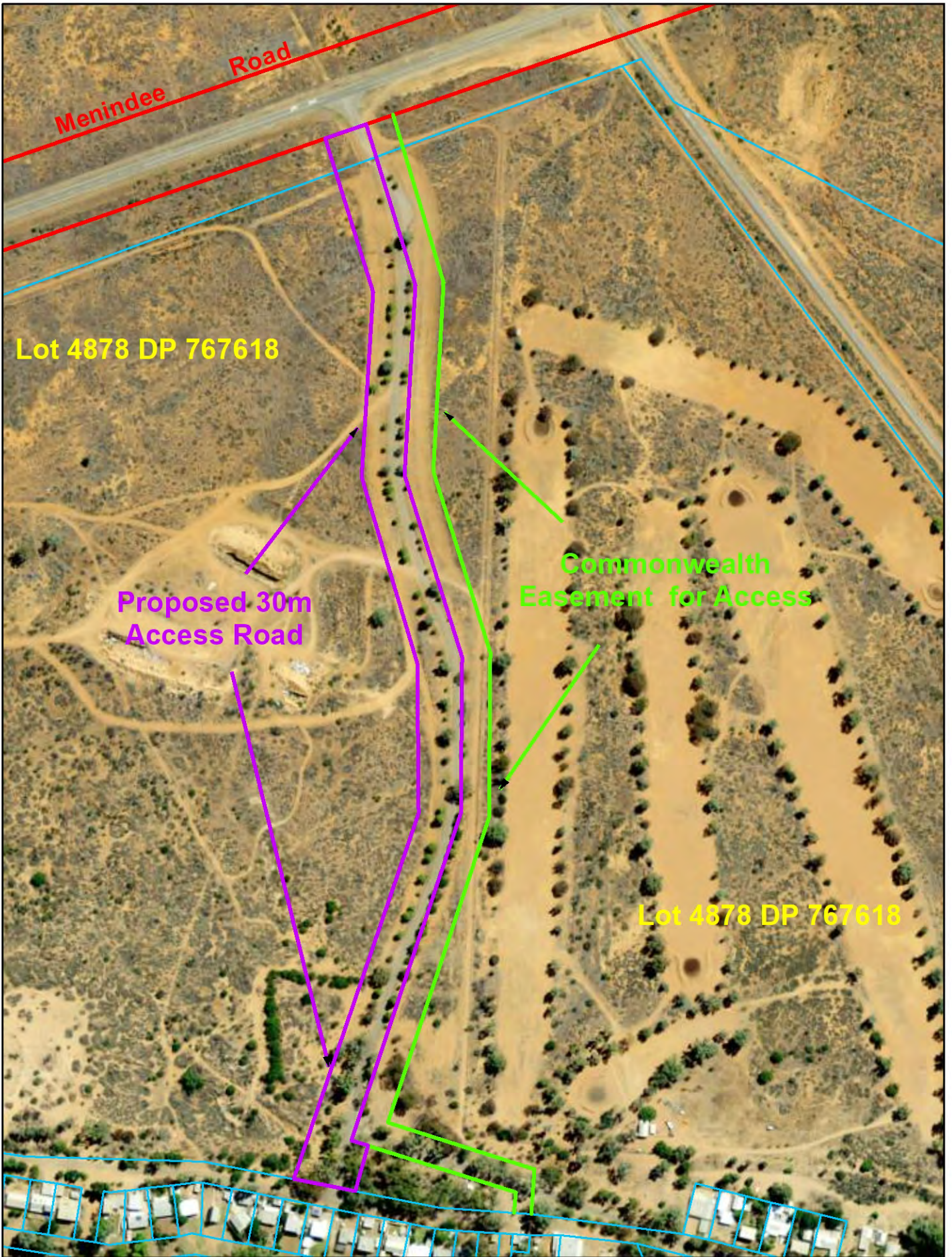
